The Stewards, having received a report from the Race Director about unsportsmanlike and abusive conduct by the Team Representative of Copeland Motorsports – Dean Copeland - toward a series official, requested a report from the involved official. Mr. Copeland, and the official, were interviewed by the Stewards.


Having heard from the involved parties, and having reviewed the written report of the incident, the Stewards have reached the following decision:

The Stewards find that Mr. Copeland was in violation of Sporting Regulations Article 19.4 – behaviour that is unsporting and does not respect the spirit of the Series.

Mr Copeland is issued a \$2500 fine, which is suspended, and will be expunged at the conclusion of the 2020 Series season provided that there are no further incidents in violation of Article 19.3 during that time.

The Competitor is reminded of his right of appeal (Sporting Regulations Article 18) except where the penalties which are not susceptible to appeal (Article 18.3 of the Sporting Regulations).
